Mr.Ramon Sierra resident of Anapra asked Board Members and CRRUA staff to ask for help when needed from people who have extra engineers, also request that whenever there is something wrong going on with the water or any of the plant to mail out notices as soon as possible so that residents know what is going on

Mrs. Olga Nunez, Councilor of City of Sunland Park stated that CRRUA was putting the health of Sunland Park resident in danger because of the arsenic, also stated that it is hard to believe that the Board Members were not aware of what was going on with the arsenic plants not working properly
