The other item is the contract between CRRUA and Doña Ana County for contract and fiscal management and administrative services has expired October 31, 2021. The contract if desired to be continued, it would need to be re-negotiated as soon as possible.

Mr. Michael Martinez, City of Sunland Park City Manager stated that City of Sunland Park agreed with Mr. Fernando Macias, Doña Ana County Manager and stated that it is for the best interest of CRRUA.
