WATER AND WASTEWATER CONNECTION CHARGES

The One-Time Charge for water meter size greater than 2" shall be determined on a case by case basis. Volume and characteristics of wastewater discharge, pretreatment requirements, and the cost to the wastewater utility's infrastructure and treatment capacities will be factored into this contract determination

MULTI SERVICE LINES WITH INDIVIDUAL METERS:

A customer may request individual meters to be installed for a multi-unit property. A master meter shall be required and the One Time Charge for applicable meter size will be applied. For each individual meter requested to be installed beyond the master meter, a Multi-Unit Surcharge will be required at \$157.00 per unit and \$20 per month per unit.
